## FREE MEMBERSHIP

1. The member of association can be:
  - a) individual, which is fully capable for legal acts and is upright,
  - b) legal entity, which was formed in accordance with the law and has legal capacity, in association is acting by its statutory body.
2. Association accepts and writes into the list of the association members individuals and legal entities, who fulfill the legal assumptions to become a member of the association, and that in a one month time by the day of apply the written application of the candidate. The application form of the candidate includes his personal, professional and contact details. The acceptance of the member to the association is done by Executive Committee of the association.
3. The membership in the association can have following forms: individual, collective and honorary.
  - a) The individual member of the association can become every FMST SUT graduate (before the Faculty of Machine Technology of Slovak University of Technology), who properly and successfully finished the study, agrees with the statutes of the association and shows a will to become its member by applying the application form of the candidate, as well as every third authorized person. The acceptance of the member to the association is decided by the Executive Committee according the paragraph 2 this article of this statutes. Against his decision it is possible to recall towards the General Assembly of the association.
  - b) The collective member of the association can become the group of graduates (minimum of two), who asks for the membership together, or legal entity who agrees with the statutes of the association and shows the will to become a member by applying the candidate's form. About the acceptance of the member is decided by Executive Committee according the paragraph 2 this article of this statutes.
  - c) The honorary membership is granted by the Executive Committee of the association to person, who by the significant and irredeemable way contributes towards the fulfilling of the FMST SUT purpose, and spreading its reputation, the Executive Committee his special membership considers as an expression of award.
4. The membership in the association expires:
  - by the leave of the member also without stating the reason till the date of delivery of his written notice about leaving the association to Executive Committee
  - by the death of the individual or the expiration of legal entity
  - by deleting member by Executive Committee of the association in following cases: a) if the member of the association was incapacitated for legal acts or his capability for legal acts was limited, b) if the member of the association is inactive, because of being in an unknown place
  - by excluding the member by Executive Committee (Board) of the association, if:
    - a) the member of the association was legally convicted of an intentional crime,
    - b) the member of the association was legally convicted of a crime, which he committed while performing an activity in association,
    - c) despite warning the member repeatedly grossly contravenes the statutes, obligations of membership and commitments of the association,
    - d) despite warning the member by his activity repeatedly damages the reputation of FMST SUT,
    - e) the member of the association did not pay the prescribed membership fee for two consecutive years,
5. Honorary members of the association have all rights and obligations of the members, however they are exempt from paying the member contributions.

## AIM OF ASSOCIATION

1. associate STU MTF graduates and friends on the basis of willingness and personal interest with focus on developing appropriate tools for *Alma Mater* support by former students, partners and Faculty enthusiasts
2. constitute conditions for STU MTF activities support
3. prepare conditions and space for mutual communication and cooperation of former and current Faculty students, teachers, researchers, other Faculty employees and enthusiasts with focus on mutual and versatile help, support, and knowledge and information exchange
4. enhance and provide expert, scientific and technical information of specialized Faculty profiles as well as of other fields beneficial for the Faculty and its graduates
5. facilitate the development of STU MTF graduate profile so that it meets the requirements of practice as well as the prospects of its future trends as much as possible
6. prepare conditions and support lifelong continuous learning and further improvement of STU MTF graduates qualifications and specialization
7. prepare conditions for virtual as well as personal communication Of STU MTF ALUMNI – Bank of Quality members
8. elaborate and administer the database of the Association members and Association activities beneficial on the Faculty mission and STU MTF ALUMNI – Bank of Quality
9. provide the Association members with information on conferences, symposia specialized seminars, exhibitions as well as on other specialized, social, cultural and sport events (co)-organized by the Faculty
10. support efficiently STU research and development results implementation in practice via the Faculty graduates and at the same time reflect the practical results in the Faculty research and development activities
11. cooperate with the Association members in connecting foreign subjects in information exchange as well as in other forms of knowledge discovery
12. cooperate with similar organizations in the Slovak Republic and abroad
13. prepare conditions for feedback in terms relevant information acquisition on STU MTF graduates implementation as well as on the requirements laid on graduates of particular study stages via forums on the communication portal of STU MTF ALUMNI – Bank of Quality included in the Faculty website
14. provide presentation of successful graduates and companies cooperating with STU MTF, transfer know how in all STU MTF fields of development
15. develop traditions and culture of University and Faculty life within as well as beyond the European Union
