

Dean's Regulation No. 5/2020 - SD 12/08/2020

Rules for evaluating scientific and research activities of the MTF STUcreative employees

STU MTF

Article 1 Introductory provisions

(1) The rules for evaluating scientific and research activities of the MTF STU creative employees stipulate the following items:

a) method of evaluating scientific and research activity in the conditions of MTF STU,

b) minimum criteria for meeting the work requirements in the field of scientific research,

(c) measures in case of non-compliance with the minimum criteria for meeting the work requirements in the field of scientific research.

- (2) These rules represent a tool for standardization and evaluation of the creative workers'work performance in the field of scientific, research and other creative activities, as well asmeeting the Faculty goals defined in strategic documents.
- (3) The evaluation of the scientific and research activity of creative workers provides anoutcome for:
 - a) granting personal allowances,
 - b) granting special bonuses,
 - c) issuing reprimands for failure to meet theworkrequirements,

(d) reducing working load or termination of employment in the event of repeated failure to perform workassignments.

- (4) Evaluation of scientific and research activities of the MTF STU employees is conducted once a year, usually in March, in the following areas:
 - a) publication activity,
 - b) responses to publication activity,
 - c) grant and project activity,
 - d) other scientific, professional and organizational activities.

Article 2 Publication activity

- (1) Publication activity shall be evaluated in accordance with Annex 1. Evaluated shall be the publications registered in the Central Library System in the year when the evaluation is performed and in the year before.
- (2) In the event ofmore than one author of a publication, the point evaluation shall consider the percentage of individual authors registered in the University Library System.



(3) The sum of points allotted to individual evaluated publications represents the result of the employee evaluation for publication activities.

Article 3 Responses to publication activity

- (1) Responses to publication activity are evaluated in accordance with Annex 1. The evaluation includes the responses registered in the Central Library System and published in the year for which the evaluation is performed. Selfcitations are not included in the evaluation.
- (2) The sum of points allotted to individual responses represents the result of the employee evaluation for responses to their publication activity.

Article 4 Grant and project activities

- (1) The creative staff'sgrant and project activities carried out at the Faculty are evaluated by the product of the points listed in Annex 1 and one hundredth of the research capacity belonging to individual projects. The evaluation includes the projects and project proposals duly registered in the relevant Faculty Department, within the scope of the employee's annual work fund.
- (2) The sum of points allotted to individual projects represents the result of the employee evaluation for the grant and project activities.

Article 5 Other scientific and professional activities

- (1) Other scientific and professional activities shall be evaluated in accordance with Annex 1. Only the activities documented in writing shall be included in the evaluation.
- (2) The sum of points allotted to individual activities represents the result of the employee evaluation for other scientific and professional activities.

Article 6 Overall evaluation and minimum criteria for meeting the work requirements

(1) The overall evaluation of a creative worker represents the sum of points allocated according to Art. 2 Par. 3, Art. 3 Par. 2, Art. 4. Par. 2 and Art. 5 Par. 2.

(2) The minimum criteria for meeting the work requirements in the field of scientific research are set out in Annex 2.

(3) The method of determining the minimum criteria for the achieved number of points for the employees performing managerial activities is specified in Annex 3.



- (4) In the case of part-time workers, the minimum criteria specified in Annex 2 shall be multiplied by the amount of their working load.
- (5) In the case of workers who have been working only part of the year (maternity leave, parental leave, etc.), the minimum criteria specified in Annex 2 shall be multiplied by one twelfth of the number of months worked.
- (6) The ratio of the number of achieved points in the overall point evaluation versus the number of the points corresponding to meeting the minimum criteria for meeting the workrequirements, represents the personal effectiveness of a creative worker in scientific research, and is determined as a percentage.
- (7) The prerequisiteof meeting the workrequirements of a creative worker in scientific research is to achieve personal effectiveness of at least 100%.

Article 7 Measures in case of non-meeting the minimum criteria for workrequirements in the field of scientific research

(1) The results of the scientific work evaluation form part of the evaluation of meetingthe workrequirements of creative Faculty staff, and are taken into account in their financial evaluation.

(2) Failure to meet the minimum criteria pursuant to Art. 6, par. 7 is considered a non-compliance with the workrequirements of creative workers. In such a case, the manager of the relevant workplace will apply measures (written notice of non-meeting the workrequirements, reduction of financial evaluation, reduction of working hours and termination of employment), depending on the degree of meeting the requirements of minimum number of points for publication activities, degree of achieved personal effectiveness and the period of non-compliance with the established minimum criteria.

Article 8 Common, transitional and final provisions

(1) The rules for evaluating the scientific and research activities of creative workers were approved by the MTF STU Management on 27 October 2020.

(2) The scoring system for the scientific research activities evaluation (Annex 1) and the criteria for meeting the workrequirements (Annex 2) may be updated in the light of changes in the academic environment in the form of amendments to this Regulation.

(3) This Regulation shall enter into force upon the day of its publicising.
