Uhra Student Hostel and RÚVZ, the STU MTF M. Uhra **Student Hostel's Director** is entitled **to cancel their accommodation in the STU MTF M. Uhra Student Hostel** without appeal.

Uhra Student Hostel will ensure necessary services (catering, hygienic and health goods) for the student/employee against the payment.

In case there will be **not sufficient free accommodation capacity** of designated isolation rooms at the STU MTF M. Uhra Student Hostel, the isolation of the whole room will be mandatory.

The STU MTF M. Uhra Student Hostel will increase the cleaning of the premises where the person with confirmed disease has moved during the **last 48 hours** before s/he has to start the mandatory home isolation.

In case the red phase has lasted longer than one week, it will be necessary to consult the interruption of the STU MTF M. Uhra Student Hostel operation and stop the accommodation of students.
