

**CAUTIONARY SYSTEM – FOLLOWING THE HYGIENIC AND EPIDEMIOLOGIC MEASURES FOR ACCOMMODATED STUDENTS AT STU MTF M. Uhra Student Hostel TRNAVA**

Uhra Student Hostel on the situation and the follow-up procedure. - <b>STU MTF M. Uhra Student Hostel recommends</b> the student and their roommates <b>to leave the STU MTF M. Uhra Student Hostel</b> without check-out, the return to the STU MTF M. Uhra Student Hostel will be possible according to the pandemic situation - if the students do not leave the STU MTF M. Uhra Student Hostel, they <b>MUST minimise their movement within the STU MTF M. Uhra Student Hostel premises</b> .
<b>Foreign students from “BK”</b>				-s/he must contact their physician or RÚVZ via the phone, - subsequently, s/he must inform the STU MTF M. Uhra Student Hostel on the situation, - <b>STU MTF M. Uhra Student Hostel recommends</b> the student <b>to leave the STU MTF M. Uhra Student Hostel</b> , or the STU MTF M. Uhra Student Hostel will move the foreign student to a <b>designated isolated room</b> in the STU MTF M. Uhra Student Hostel.

**Essential rule:** Students/employees will be accommodated **under standard conditions** and the STU MTF M. Uhra Student Hostel and the Student Hostel Management will assign rooms from its accommodation capacity for the foreign students having subjective symptoms and who cannot leave for home, or by whom the transfer home will be impossible, and whose symptoms will not require hospitalisation.

**Sanctions:** In case that the accommodated persons fail to follow the epidemiologic recommendations and regulations of the STU MTF M. Uhra Student Hostel and RÚVZ, the STU MTF M. Uhra **Student Hostel’s Director** is entitled **to cancel their accommodation in the STU MTF M. Uhra Student Hostel** without appeal.

**Basic rule:** The person with **suspected COVID-19 Disease** can be determined only the **relevant RÚVZ or physician**. Such persons are subject to mandatory home isolation and the STU MTF M. Uhra Student Hostel will ensure necessary services (catering, hygienic and health goods) for the student/employee against the payment. The STU MTF M. Uhra Student Hostel will increase the cleaning of common premises and disinfection of common touch surfaces to **three times a day**.

**Basic rule:** the person **with CONFIRMED** COVID-19 Disease can be determined only by the relevant RÚVZ or the physician. The persons have to undergo the **mandatory home isolation** and the STU MTF M. Uhra Student Hostel will ensure necessary services (catering, hygienic and health goods) for the student/employee against the payment.

In case there will be **not sufficient free accommodation capacity** of designated isolation rooms at the STU MTF M. Uhra Student Hostel, the **isolation of the whole room will be mandatory**.

The STU MTF M. Uhra Student Hostel will increase the cleaning of the premises where the person with confirmed disease has moved during the **last 48 hours** before s/he has to start the mandatory home isolation.

In case **the red phase** has lasted longer than one week, it will be necessary to consult the **interruption of the STU MTF M. Uhra Student Hostel operation and stop the accommodation of students**.
